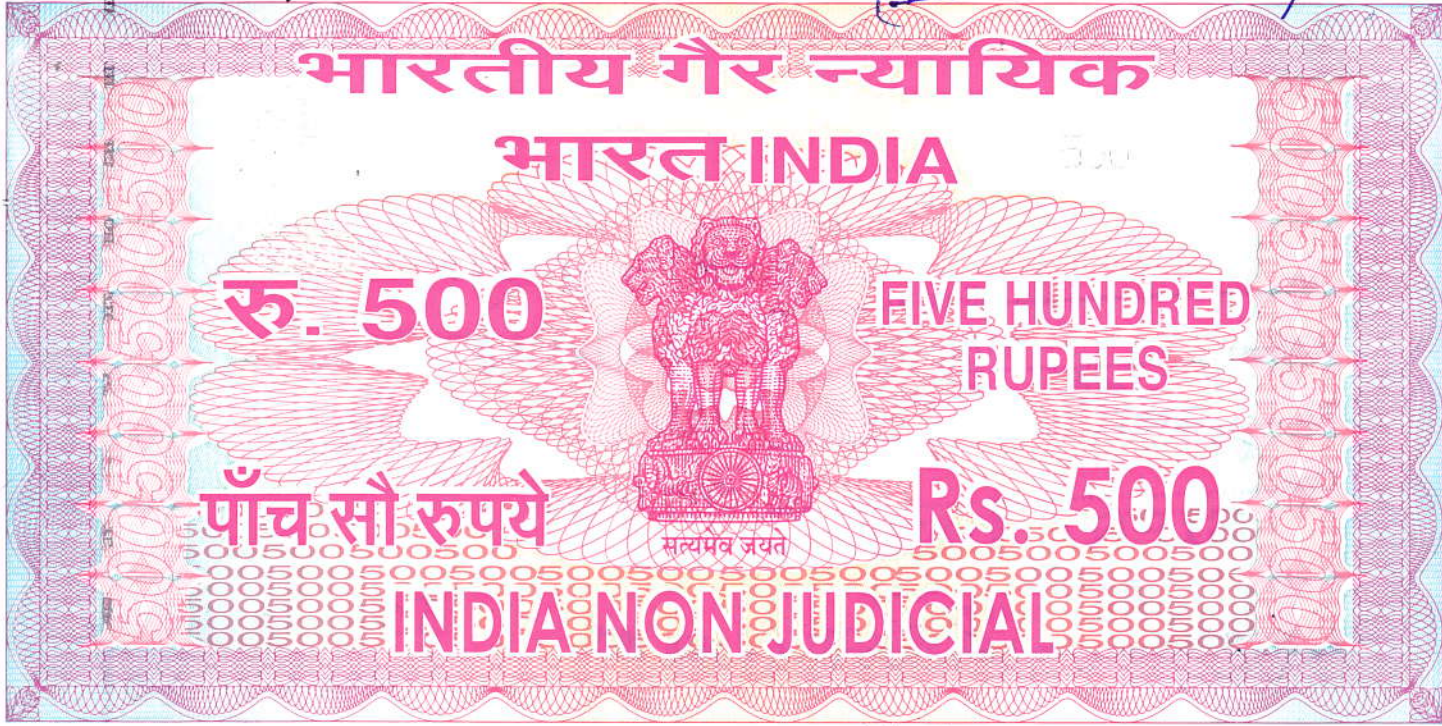

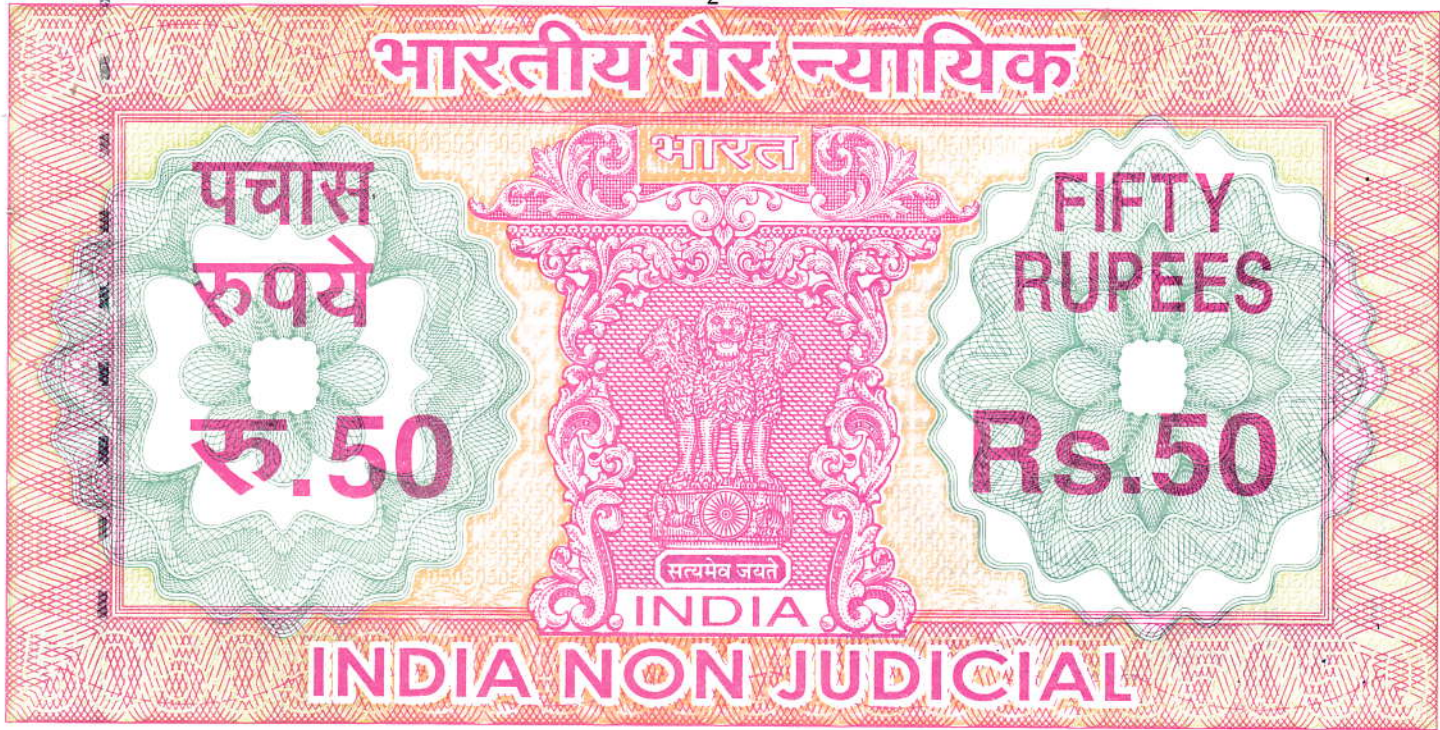

WHEREAS Authors of the Trust are possessed of and otherwise well and
 sufficiently entitled to the sum of Rs.10, 000/- - (Rupees Ten Thousand
 only) hereinafter referred to as said property.

AND WHEREAS the Authors of the Trust desire to irrevocably endowing the
 said founds upon trust for public, educational, and cultural, purposes, as
 hereinafter expressed and contained in this presents and in pursuance of
 such desire have already transferred paid and handed over the said property
 to the trustees mentioned below.

AND WHEREAS it is the desire of the Authors of the Trust that the Corpus
 of the Trust may be further augmented from time to time by flow of funds

and other assets including movable and immovable and any other kind by way of Gifts, or Donations, acquisitions, allotments, grant exchange or otherwise etc.,

AND WHEREAS the following persons are appointed to be trustees for holding the said property in Trust for the purposes detailed in this Trust Deed:

1. Mr. Sanath Majhi (Author/ President)
2. Mr Souren Naskar (General Secretary)
3. Mr. Subhas Mazumdar (Treasurer)

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. **NAME** The Trust hereby established shall be named as: **ACHARYA CHARITABLE TRUST (An Educational Trust and charitable Trust, Non profitable, non - commercial, not Political)**
2. **PLACE** Office of the Trust shall be situated at Mozepur, P.O.- Duttapur, P.S.- Tarakeswar, Dist.- Hooghly WEST BENGAL - 712410., West Bengal or at such other place in India as the Trustees may from time to Time think fit.

3. **OBJECTS** -The objects for which the Trust is founded are:

All are charitable purpose as defined in charitable Trust Act 1920

and Income Tax Act 1961 as follows:-

- (a) To establish, maintain and run Preparatory, Primary and Secondary Schools, Colleges, Social service centers, Industrial and various Vocational Training centre.
- (b) To establish, Training Centre, and allied education institutions.
- (c) To provide training of Football, Cricket, Volley Ball, Badminton, Swimming Etc. himself or can hire expert or can tie up with another Organisation/ Institution for better-to-better training.
- (d) To establish, Cultural, and Social Institutions for the benefit of the Society.
- (e) To spread for promotion of education and learning in all branches more specifically in Science and Technology.
- (f) To advance Indian Culture and Literature, Service of this Country for the benefit of our Nation.
- (g) To Trust can start, establish, run tie up a charitable hospital and multi facilities hospital for the benefit of society without profit motive.
- (h) To trained teachers and workers in ideals and practice of the true spirit of the education and learning.
- (i) To establish research and training centre for the furtherance of education/learning in its various fields and branches.

- (j) To undertake propaganda, training and education of the masses either of its own or in co-operation with similar Agencies working for the cause of all round development of the Society.
- (k) To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- (l) To function as a Non-communal Trust and as a secular organization.
- (m) To establish centers for employment generation.
- (n) To acquire and maintain the movables and immovable properties for achieving and said objects.
- (o) To advance any other objects of general public utility.
- (p) To confer title on eminent personality in the field of science, education, literature, etc.,
- (q) To establish the collage & colleges to impart education in the area of higher education especially the emerging field like, Electronics, Bio-technology, and other allied fields. The trust shall be an irrevocable public educational, cultural trust for the benefit of all persons belonging to whatever community irrespective of Caste, Creed or Religion, the Trustees shall stand possessed of the said amount of corpus endowed by the Authors of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription,

endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

- (r) Trust can run one and more institution for different type and in different name in the field of education, training, technical training, vocational training, mass media, all type of journalism, acting in theater, cinema, mimicry, video and still photography and also the training with the help and co-operation, joint venture with central govt., state govt. any institution, NGO and other.
- (s) Trust can make a new institution, college, university himself or with tieup and association with nation, international, NGO and institution.
- (t) Trust can issue certificate after completion the course.
- (u) Trust can run and issue the certificate of certificate , Batchelor and master degree of course run by trust. COMMENCE FROM 01-03-2025.

4. NUMBER OF TRUSTEES:

The number of Trustees including the Author of the Trustees shall not be less than 3 and not more than 5 persons. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

5. TERM OF OFFICE OF THE TRUSTEES:

Sanath Mayhi

These Trustees shall hold office for such duration as may be specified by the board of trustees.

6. PRESIDENT:

There shall be a president for the administration of this trust, nominated by the board of Trustees, who shall be one amongst trustees as specified in para (4) above for such period, in such manner as may be specified in this behalf.

7. MANAGING TRUSTEE:

- (i) The day-to-day administration of the Trust shall be looked after by the Managing Trustee under the guidance, control and supervision of the Board of Trustees.
- (ii) The Board of Trustees shall nominate one amongst the trustees as specified in para (4) above to be the Managing Trustee, who shall hold office for such period, as may be decided by the Board of Trustees.
- (iii) The Managing Trustee shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.

8. VACANCIES:

Any vacancy among the Members of the Board of Trustees may be filled by the trustees as specified in para(4) above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

9. TERMINATION OF OFFICE OF THE TRUSTEES:

- (a) Trustee shall cease to hold office:
 - i) if he dies,
 - ii) if he resigns,
 - iii) if he is adjudged insolvent or found guilty of an offence involving moral turpitude.
 - iv) if he is found to have acted against the interest of the Trust.
 - v) if it is unanimously decided by the Trustees specified in para(4) above that his continuation in the Office is against the interest of the Trust.
 - vi) Upon expiry of the period up to which the Board of trustees have nominated the trustee.

10. MEETING AND PROCEEDINGS OF THE TRUSTEES:

The Trustees shall ordinarily meet once in 6 months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.

- 11. NOTICE:** 15 Clear days Notice shall ordinarily be given in writing for a meeting of Board of Trustees.

- 12. QUORUM:** The Quorum for the Meeting of the Board of Trustees shall be 2 numbers quorum is required for a meeting adjourning for want of Quorum.

A minute book shall be kept by the Managing Trustee. Minutes of entry into the office of every new trustee and of all proceedings of the

meeting of the 3 board of trustee shall be entered in the minute book and shall be signed by the President of the Meeting.

13. VOTING:

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The President of the Board of Trustees shall have a casting vote in the event of equality of votes, in addition to his own.

14. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

- (a) All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.
- (b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:
 - (i) To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.

- (ii) To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- (iii) To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
- (iv) (a) To raise loans, to receive monies, securities or other movable property on behalf of the Trust.
(b) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
- (v) To award scholarship and make donations calculated to promote the objects of the Trust.
- (vi) (a) To enter into contracts, or engagements on behalf of the Trust.
(b) To consider such proposals submitted by Sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- (vii) To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
- (viii) To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties

or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.

- (ix) To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- (x) To appoint Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
- (xi) To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- (xii) To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees as per Section 47 of Trust Act.
- (xiii) To frame Bye-Laws and such other regulations as are required for achieving its objectives.
- (xiv) Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely

- (a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
- (b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
- (c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
- (d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
- (e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
- (f) Cost and expenses of keeping the trust property in good condition.
- (g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
- (h) The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
- (i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance

with the objects and purposes hereof or which may be incidental thereto. After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

15. BANK ACCOUNT:

- (i) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of **ACHARYA CHARITABLE TRUST** and institute run by trust **ACHARYA INSTITUTE OF MASS COMMUNICATION** or some other Institution or Organization run by the Trust time to time such accounts shall be jointly operated by the President and Managing Trustee.
- (ii) The Trust may open Bank Account/s in the name of institution/organization founded by the Trust. Such Bank Accounts shall be operated by such persons as authorized by the board of trustees from time to time.

16. APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential

accommodation or any perquisites to any trustee in connection with the work carried out by him/her for the purpose of the Trust.

17. ACCOUNTS:

The Trustees shall maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust. The Books of Account of the trust shall be audited by a qualified auditor or a Chartered Accountant every year i.e., commencing from 1st April to the 31st March of next year.

18. DEFECTS OF PROCEDURE IMMATERIAL:

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

19. AMENDMENTS:

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80G of the Income Tax Act, 1961 as amended from time to time.

21. FUNCTION OF THE TRUST :

- a) **The trust will never acts which are illegal and unlawful in nature and also opposite to the public policy and contrary to the law of the country in connection with Sec 4 for which the trust and the**

trustees are responsible for that and come under the all punishable Law (CRPC and IPC).

b) The trust will never acts like Micro financing and Money Laundering (Act 2012) Economic offence/crime in connection with sec 20 and in nature and shall not obtain any donation or like that from abroad without getting the permission of FCRA Act from the Central Govt./ the competent Govt. authority which the trust and the trustees are responsible for then and come under the all punishable law (CRPC and IPC).

c) The Trust shall never argument and/or borrow money from the Public or open market by announcing different attractive Financial investment schemes.

d) All donation and Gift from any one individual or Institution or any corner shall be accepted by maintaining all legal norms and valid documents/receipts.

22. Beneficiary The trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of cast religion or sex, colour or place of birth the General public and community at large(the beneficiaries)

23. Dissolution In the event of dissolution of the Trust the entire

Trust funds shall be realized and first be used for payment of liabilities of the Trust, The Assets left it any shall be disabused to other Trust or Association having approval of commissioner of income tax and in no event it shall be distributed in any manner to any of the Bound of Trustee or their relations or related /persons.

24. Area of jurisdictions of operation : - Area of jurisdictions / operation of the Trust in the whole of Indian but preferably in the state of West Bengal.
25. Remuneration of Trust : The trustee will not be able to entitled to receive/get any Remuneration as Trustee but may reimburse themselves of all expenses actually incurred by them in connection with the trust or their duties thereto subject to passed by the Board of Resolution and approved by the income Tax Department.
26. The Settlor and the Trustees cannot claim any ownership rights Title and interest of the present and Future Trust property.
27. **APPLICABILITY OF TRUST ACT:**

The provisions of the Indian Trust Act 1882 (Section 4) shall apply to all matters not specifically mentioned in these presents.

28. LAWFUL PURPOSE -

A trust may be created for any lawful purpose. The purpose of a trust is lawful unless it is -

(a) forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) is fraudulent, or (d) involves or implies injury to the person or property of another, or (e) the Court regards it as immoral or opposed to public policy. Every trust of which the purpose is unlawful is void. And where a trust is created for two purposes, of which one is other unlawful and the two purposes cannot be separated, the whole trust is void.

29. BANK ACCOUNT :

The Chairperson/Chairman (Managing Trustee) and Secretary or Chairperson/ Chairman (Managing Trustee) and Treasurer by a proper meeting Resolution passed shall jointly open & operate the Bank Account/ Accounts on behalf, in the name of the Trust. In their absence any of the Trustee and or any Member of the Trust may be authorized by the Board of the Trustee by a resolution to operate the bank accounts. One or more Bank Accounts may be opened in any Bank and or Banks in the name of the Trust and provision should be there to open Bank accounts at Head Office, Corporation Office, Registered Office, State Office, Regional Office, Zonal

Office, Branches/units of the Trust as may be deemed fit by the resolution of the Board of Trustee.

30. APPLICATION OF INCOME TAX ACT :

All clauses herein are intended to secure exemption from Income Tax on the income of contributions and donations to the Trust and any clause or portion of this Deed of Trust which is consistent with or repugnant to the sections of the Income Tax Act, 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.

31. THIS TRUST IS DECLARED IREVOCABLE:

32. DISSOLUTION:

In the event of dissolution of the Trust, the entire Trust funds shall be realized and first ~~be~~ used for payment of liabilities of the Trust. The assets left if any, shall be disbursed to other Trusts or Associations having similar objectives after obtaining previous approval of Commissioner of Income Tax and in no event it shall be distributed in any manner, to any of the Board of Trustee or their relatives or related concerns.

All aims/objects/purpose of the trust herein stated above shall come into effect/force after necessary approval of the competent govt. authority in the cases where affiliation / permission/ license/ sanction is required.

SCHEDULE

At present the trust has no movable or immovable and landed property save and except the trust value amounting Rs.10,000/- (Rupees Ten Thousand Only) in its own name and no immovable and landed property is being settled in favour of this trust by this document.
