Scope of Services:

- Arrange Trained Staff for training of Students
- Send Training Videos and Photographs to Gramin Skill Development Mission

Contract Period

This Agreement is effective when signed by Training Center **Hrs Group Of Education** and Gramin Shiksha representatives ("Effective Date") Initial term of this Agreement is One Year (12 Months) starting from the Effective Date.

Billing and Payment

Payments are due within 15 days of raising the invoice. Services will be terminated if payments are not received within the terms, after serving a 5 days' notice via email or fax.

Representations and Warranties General.

Each Party represents and warrants that it has the right and authority to enter into this Agreement, and that by entering into this Agreement, it will not violate, conflict with or cause a material default under any other contract, agreement, indenture, decree, judgment, undertaking, conveyance, lien or encumbrance to which it is a party or by which it or any of its property is or may become subject or bound.

Compliance with the Laws. Each Party represents and warrants that no consent, approval or authorization of or designation, declaration or filing with any governmental authority is required in connection with the valid execution, delivery, and performance of this Agreement. Each Party shall, at its own expense, comply with all laws, regulations and other legal requirements that apply to it and this Agreement, including copyright, privacy and communications decency laws.
