DURATION OF EDP PROGRAMME

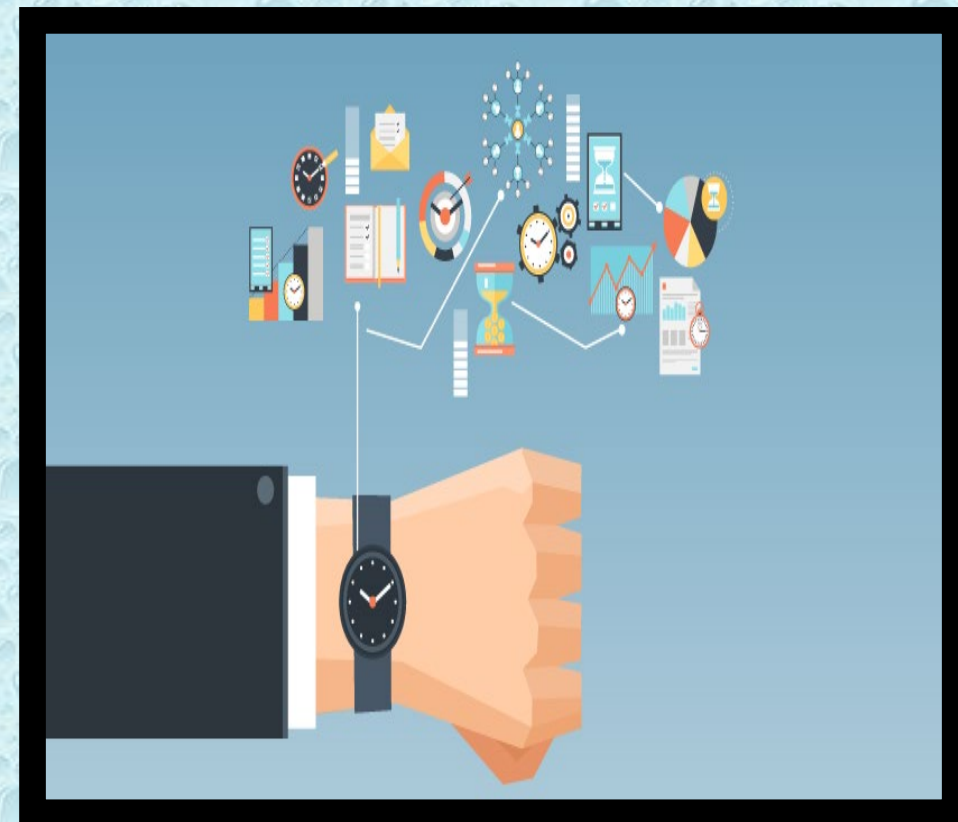
Duration of this training will be minimum 10 days and maximum 15 days

The time to answer each question is 60 second

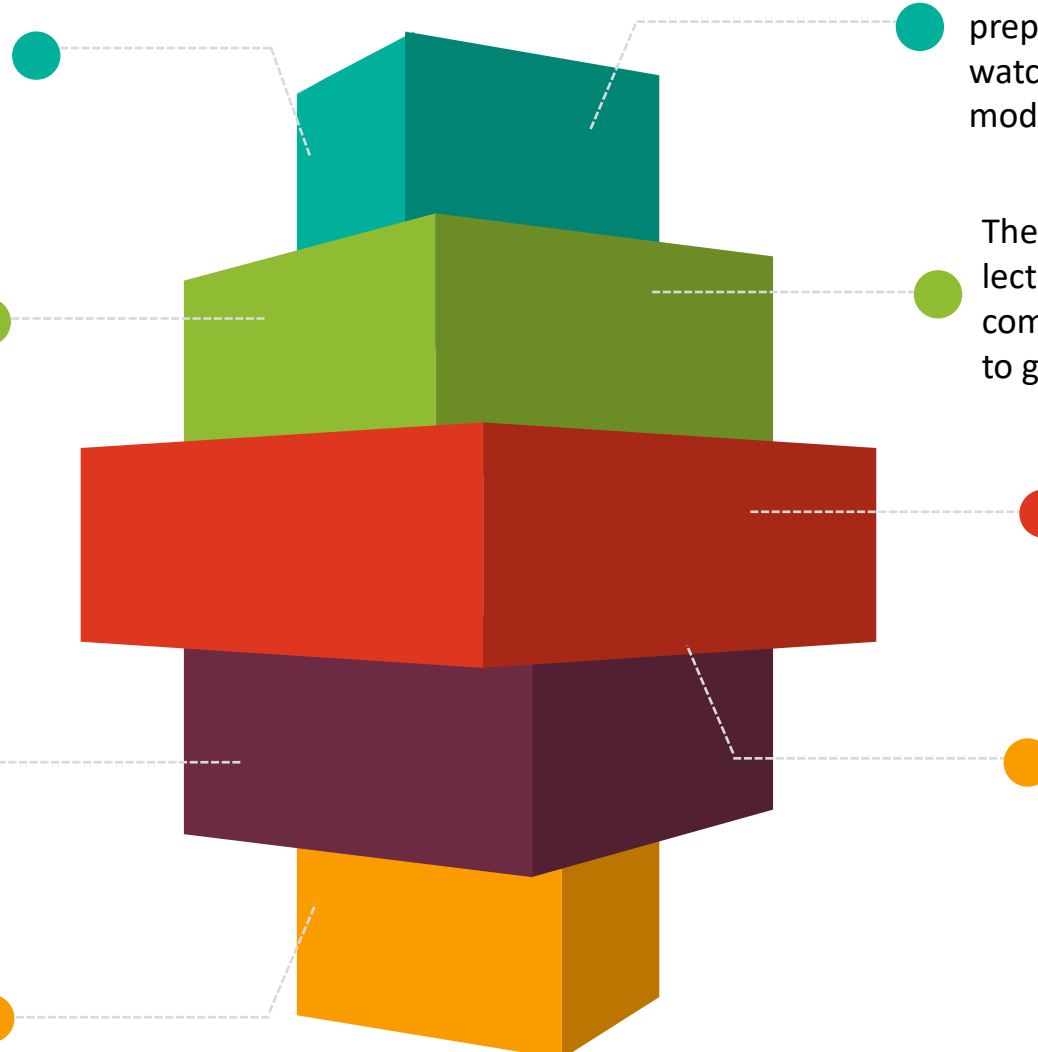
Every question is compulsory to answer, you can't skip it.
